### Notice Concerning GRESB Real Estate Assessment Results

MORI TRUST Hotel Reit, Inc. (“MORI TRUST Hotel Reit”) hereby announces that it participated in the 2021 GRESB Real Estate Assessment and acquired the status of “3 Stars” and “Green Star”. It also acquired the highest “A Level” for GRESB Public Disclosure as described below.

#### Details

##### 1. Outline of GRESB

GRESB is an annual benchmarking assessment to measure ESG (Environmental, Social and Governance) integration of real estate companies and funds, as well as the name of the organization that carries out the assessment. It was founded in 2009 by a group of major European pension funds that played leading roles in launching the Principles for Responsible Investment (PRI). Currently, more than 140 Investor Members use GRESB data for selecting investment destinations and engaging with investees, and several institutions from Japan including the Government Pension Investment Fund (GPIF) utilize GRESB Assessment results. In 2021, 1,520 listed or private real estate companies/funds participated in the 2021 GRESB Real Estate Assessment.

##### 2. Assessment Result

###### (1) GRESB Real Estate Assessment

In the 2021 GRESB Real Estate Assessment, MORI TRUST Hotel Reit received “3 Stars” in GRESB Rating, which is based on GRESB Overall Score and its quintile position relative to global participants. It also won “Green Star” designation by achieving high performance both in “Management Component” that evaluates policies and organizational structure for ESG promotion, and “Performance Component” that assesses environmental performance and tenant engagement of properties owned. In evaluating MORI TRUST Hotel Reit, setting of goals/policies and a business execution system relating to sustainability, risk assessment system and initiatives for tenants and community, etc. were evaluated.
